Hospital Auxiliary

The Hospital Auxiliary and the Foundation share the common goal of keeping our hospital equipped. This year's annual donation helped purchase a pharmacy custom fridge (\$5,000), Triage Bench and signs for the ER department (\$7,132), Cast Saw and Vacuum for the ER (\$4,269), Commode (\$2,000), 4 Stretcher Mattresses (\$3,600) and a Nerve Stimulator (\$1,223).

Sometimes our days can be so full and busy that we forget how fragile life really is. Our lives could literally change in a heartbeat from an illness or an accident. **Could you imagine if we did not have a hospital in Kincardine** and we had to travel out of town for the simple things (blood tests, ultrasound, X-ray, minor surgery)? Travelling out of town to have tests done or to see our loved ones in the hospital might not be a possibility if the weather conditions were not good.

Our goal is to raise money to enable our Kincardine Hospital to continue to provide the very best care for you and your family if you ever need it. Because of your generosity over the years, we have raised over **\$185,680** through our Annual Christmas Ornament Campaign! This year the proceeds of our Christmas Campaign will go towards the purchase of an Ultrasound Machine (\$203,780). The present machine is at the 'end of life' and is no longer eligible for service. Kincardine is at risk of losing this service in the Hospital if this item is not purchased.
